#### Revised ARM Sections

Several revisions to the ARM were released today as follows (Note that the Update Guide section located at the beginning of the section provides detailed information about the topics addressed in this release):

**Section 4**, *Eligibility Determination* was updated to remove "designated state-funded pre-kindergarten programs" as an acceptable type of other source categorical eligibility.

Substantive guidance changes and clarifications were made to **Section 17**, *Procurement and Section 17c, Cooperative Purchasing* regarding the following:

- Aggregate for micro-purchasing
- · Buy boards and subscription services
- Conflicting program regulations
- Cooperative agreements
- Cost analysis
- Forecasting
- Inadequate competition
- Noncompetitive procurement
- Off-bid purchases
- Third-party cooperatives

Finally, the definitions for "aggregate purchase amount" and "micro-purchase method" were updated in the following sections:

• Section 15, Program Integrity

- Section 16a, Contract Management
- Section 17a, Procurement Procedures
- Section 17b, Buy American
- Section 18, Food Service Contracts

## **TX-UNPS Updates**

#### 2021-2022 Universal Breakfast Program Waiver

The Universal Breakfast Program Waiver application is now open!

The application period runs from **March 15 – June 30, 2021.** School district campuses and open-enrollment charter schools participating in NSLP in which 80 percent or more of the students qualify for a free or reduced-price breakfast must offer a free breakfast to each

student or seek a waiver from TDA, required by Senate Bill 376. TDA has notified all



mandated schools by email. CEs that are mandated to offer free breakfast to all students and wish to apply for a waiver should use the Universal Breakfast Waiver School Year 2021-2022 form through TXUNPS Download Forms (SNP-000). All waiver requests must be submitted by June 30, 2021. Please refer to the <u>Universal Breakfast page</u> for details and instructions or contact your Education Service Center for assistance.

#### **CEP Due Date Extension**

CEP Reports were due to TDA on June 5, 2021. If you failed to submit this report by the due date, please do so immediately to allow TDA time to prepare their required reports. TDA must post the list of possible CEP eligible districts and sites on SquareMeals.org by June 30, 2021. SFAs that intend to elect CEP for SY 2021-2022 must notify TDA by September 30, 2021. CEP election is completed via the **2022 TX-UNPS application packet**.

CEs that already submitted CEP site data, may update those submissions to reflect current identified students using the parameters described above and resubmit the form to TDA by June 5, 2021. **Do not submit data for sites designated as COVID "CV" sites**.

The CEP list reporting screen in TX-UNPS can be found by first navigating to the **Applications** tab. Once in the Applications tab, select **Community Eligibility Provision**. Select **Add** under the Action column for School year 2020-2021 located within the CEP Site List. Please ensure accurate data entry as the data will have a direct impact on claims for those that participate in CEP. The data entered is also reported to USDA and the Public.



The Program Year Calendar covers four of the main programs administered by the Texas Department of Agriculture, including the Child and Adult Food Care Program (CACFP), the National School Lunch and School Breakfast Programs (NSLP/SBP), and the Summer Food Service Program and Seamless Summer Option (SFSP/SSO).

#### Apply for TDA Grant to Expand Farm Fresh Activities in Schools!

The Texas Department of Agriculture (TDA) is now accepting applications for the **Expanding the 3E's Nutrition Education Grant**. Funds are available for public schools to use for expanding nutrition education programs. TDA's objective is to increase awareness of the importance of good nutrition and to encourage children's health and well-being through the 3E's of Healthy Living — Education, Exercise and Eating Right.

Grant recipients can use the funds to pay for <u>Farm Fresh</u> activities — fun and educational nutrition projects that will contribute to improving children's health and well-being. The maximum award is \$10,000 per school or \$50,000 per district. Applications are due **June 17, 2021**.


#### Food Safety Starts with You: Handwashing

The PY 2022 Farm to School survey is now open and available for the CEs who are participating in the Farm to School Program to submit requests. The survey will remain open until Friday, July 30, 2021 to allow participants to submit their requests to secure fresh produce through Texas Farmers and Produce Vendors.

The PY 2022 Farm to School seasonal items will be: pears, apples, grapefruits, and oranges. Due to the extreme freeze and flooding which shortened the growing season, watermelons will NOT be available for PY 2022.

# Congratulations to Child Nutrition Programs that Completed the 2021 Spring Farm Fresh Challenge


